

if you look back to the claims register shown on page 2, POC #3, you will see this creditor (above) has the same address as the creditor listed for POC #3 (the claim you are trying to amend), however, the account number listed on the second line of the address is different....

When filing an amended claim, and there is more than creditor listed on the matrix.... ALL ADDRESS INFORMATION must match.

Each name on the matrix has its own unique 'creditor number' assigned to it, even if there are multiple listings one creditor.... they each get their own unique number.

If you pick a creditor name who's creditor number does not match the one used when the original claim was first filed... you will get the error message previously noted.

Remember, several creditors may be listed on matrix more than once, it is up to you, the filer, to VERIFY the address information listed on the original claim, and pick this address from the creditor list when you file your amended proof of claim.
