19 Plaintiff filed a *Notice to Court* which states that it attaches offers of settlement to ACPE
20 and NELA (presumably to ECMC). I understand plaintiff called chamber's staff on February 3,
21 2009, to see what the court is doing with the submission.

22 There is no explanation why this was filed, but it appears that it may contravene Rule 408
23 of the Federal Rules of Evidence, Compromise and Offers of Compromise. Other than the one-
24 page cover sheet, the court has not read the 48 pages of attachments.

1 It may be that plaintiff misunderstands the courts several suggestions that he negotiate
2 with the student-loan creditors. This does not mean the court should be advised of the settlement
3 discussions.

4 Or, it may be that plaintiff feels that Docket 34 is responsive to the *Motion to Compel* filed
5 by defendant ECMC on January 15, 2009 (Docket No. 32). It is not stated as an opposition and
6 does not appear on its face to be one, so I won't presume that it is.
