10 **MEMORANDUM DECLINING TO**  
11 **DELAY EFFECT OF ORDER OF**  
12 **DISMISSAL BECAUSE OF OPPOSITION**  
13 **OF LPD BOOKKEEPING [ECF NO. 26]**

14 On April 24, 2015, the court entered an *Order Dismissing Case and Providing for Notice*.  
15 ECF No. 18. The effect of the order was stayed until Friday, May 1, 2015, at 5:00 p.m. ADT to allow  
16 for a short window of time for creditors of the debtor who had not received notice of the dismissal  
17 hearing to object. The order provided: "If an objection is filed, the court will determine if it is  
18 appropriate to continue the stay of dismissal to conduct further proceedings or, rather, allow the  
19 dismissal to go into effect."

20 LPD Bookkeeping & Accounting Services filed a *pro forma* opposition on April 30, 2015,  
21 saying it was not listed on the schedules and was still owed money which it has not been able to  
22 collect. ECF No. 26. In form, LPD's opposition was very similar to an opposition by Replacement  
23 Glass, which has been withdrawn. ECF 24 and 25.

24 The schedules were not prepared by Bob Gross. LPD was not listed on Gross's list of trade  
25 debt, Exhibit 1, to the motion to dismiss hearing held on April 23, 2015. The amount due is not stated  
26 in LPD's opposition. I conjecture it may have been a bill from the time when Meritage Management  
27 was managing Inlet Towers, and even if it was not, LPD will get quicker relief by bringing a claim in  
28 state court rather than waiting for a reorganization.
